Permittee agrees to abide by Section 20-402.2 and all the rules and regulations adopted by the Public Works Director. Permittee has the right to provide decals to individual real estate agents/employees/others acting on Permittee's behalf; however, the Permittee remains the responsible person/entity to assure compliance with this Permit.

The undersigned understands and agrees that any permit issued hereon shall be issued pursuant to the provisions of Section 20-402 of the Burbank Municipal Code, and that any or all signs authorized herein may be summarily removed by the City in accordance with Section 20-207.5 in the event of any violation of this section.
